### 6. Highways update

#### Outcome of discussion with HCC regarding village gateways:

Cllr Cox outlined the cost of the gateways as advised by Kevin Hyde of HCC, who met with Cllr Cox and two others on 30 June to discuss the feasibility of the project. Likely costs are more than the whole of the AshyPC yearly budget (over £5000) so it is

not possible to fund this without a substantial grant.

**Action**: Clerk will ask the Faccombe estate for their thoughts before pursuing any of the options or considering other solutions.

#### The Drove:

Resurfacing work has begun and it should be retarmaced very soon.

A No Through Road sign for The Drove was discussed with Kevin Hyde, who has advised that we apply for a sign via the website.
