What do we do?

- We meet every ~8 weeks, back to physical meetings in the village hall after Covid.
- We had 11 new Planning Applications in last year. Of these, 8 were approved and 3 are still pending. Also 3 tree applications approved.
- · Village details on new improved Website.
- We have email addresses for council business.

Concerns and Progress

- · Access to Newbury Newtown Road Recycling, now allowed, but costs £7 per visit.
- Resolution of planning applications taking too long, though better than earlier.
- Taxi-share is working again.
- · Verges cut for autumn only, to avoid spring flowers. No complaints so far!
- Should stiles allow access to dogs? If so, who pays?
- · We would like residents of Crux Easton to use more of our services, Taxi-share, village hall, table tennis...

Queen's Platinum Jubilee

- We are delighted that Ashmansworth will be celebrating Her Majesty's Platinum Jubilee with a Street Party with Hog Roast, children's party, entertainment, games...
- Sunday 5 th June at the Village Hall, free entry
- · Many thanks to Kieron Black for organising
- Also to Sebastian and Flora Lyon for providing commemorative mugs for all our children

Clerk's Report 2

- Once again, the lengthsman has undertaken some good work around the parish, repairing stiles, clearing footpaths and cleaning the signs and benches.
- Our mowing contractors remain the same and we hope that they continue with the great work that they have carried out to date.
- We are hoping that Covid is fading into the past now and as such are pleased to be back meeting in person, and look forward to welcoming you to our future meetings.

The Year Ahead

- The Precept for 2022/23 has increased from last year's amount by £127, to a total of £4,250, to counter the effect of lost BDBC funds.
- This is in line with budget spend predictions and will also allow the council to make some small donations.
- The Lengthsman scheme will continue for 2022/23 and we again have a budget of £1,000 to allocate to local works. Please do let us know about any suggested tasks.

Planning Issues

- Graham now a full-time member of the Development Control Committee - helpful!
- Shortage of planning expertise across whole UK.
- Local applications affecting us include Highclere, Wash Water, Sandleford, Bishops Green, Kingsclere
- · Local Plan still aiming to get a 5 year land supply.
- Highclere and East Woodhay are working on Neighbourhood Plans. We don't need this due to our Conservation Area, with a nil target for new houses.

Clerk's Report 1

- The parish council kept its precept at the same level last year, despite continued cut backs and increases from both county and borough.
- We had local elections this year and for the first time in a long time we have a vacancy on the parish council and I would encourage anyone with an interest to please contact me for further details.
- As well as some donations, with climate change very much in mind, the parish council purchased some infra-red cameras this year for assistance in identifying poor areas of insulation within your homes. Please contact us if you would like to use them.

Financial Report

- Income was as expected but less than last year due to ongoing cuts.
- Income of £285 in BDBC Grants & £4,123 Precept.
- · Expenditure roughly as expected.
- Reserves have decreased by a small amount.
 Opening balance £4,783, closing £3,802.
- Annual return figures are not yet available audit booked for later in the month, May 24th.

Election

- After last week's election, Conservative majority now reduced to 4.
- Sam Carr re-elected with a clear majority, with 55% of votes cast
- Graham Falconer is chair of Audit and Accounts.
- John Izett is portfolio holder for Property and Finance.

- · Councillor Tom Thacker, new leader Rob Humby
- 3rd most populous county 1.4 million
- Budget £2.4 billion includes schools, roads, residential homes, country parks...
- Council tax up 2.99%, including 1% for social care.

Police Report

- We have now met our latest PCSO, Joshua Revett
- He points out that we are relatively peaceful, on the boundary with Andover and close to Thames Valley
- No major issues this year 2 minor vehicle incidents
- · Concern at visits by Nottingham Knockers, including
- · He says don't deal with them but do report on 101.
- · Management of shotgun licences.

House Heating

- · Today, most use oil and/or log burners; no mains gas
- Will be discouraged/banned due to emissions + pollution
- · Propose use of heat pumps:
- Air pumps less efficient but cheaper and easier to install
- Ground pumps more efficient but more expensive to install, needing large trenches or holes to bury pipes
- Neither provides water as hot as required so ideally needs underfloor heating or some other boost
- Graham has helped a resident get a Heat Pump installed by Vivid - many thanks

Electricity

- May have solar panels on some houses but difficult on thatch or listed buildings.
- Need large <u>batteries</u> for storage of off peak or solar since most use of electricity after dark.
- · Helps EV charging. Hope costs will fall.
- · Concern at high fuel prices. May encourage insulation improvements, solar panels etc?

County Council

- Climate Change active to improve resilience and mitigation against temperature rise of up to 2°C
- · HCC's own emissions already reduced by 43%, aiming for neutrality by 2050.
- Trying to resolve issues with access to HWRC. Government consulting on improvements including DIY waste. We want free access to all sites.
- · Concern at potholes and poor white lining.
- Lengthsman support continues



Climate Emergency

- Basingstoke & Hampshire declared a climate emergency
- · Upgrading their offices and staff working from home
- We have set up a group called "Basingstoke Area Sustainability" with zoom meetings and by email
- · Impact of carbon emissions on climate change for us, fuel prices, house heating and vehicle use...
- · Impact of plastic use, need less packaging, better recycling
- Reduction of food waste, reuse of clothing, repair cafe etc
- · Avoid exporting emissions China making products with coal-fired electricity, oil based shipping and flights...

House Insulation

- · Have bought FLIR infra -red cameras that fit onto smart phones - Android or Apple
- Best used when cold outside, to show up poor insulation
- · Available free for all to borrow
- · Grants for insulation may help some.
- · Biggest problems for Listed Buildings! Need government to relax rules.

Wind Turbines - allowed here?



Travel

- Encouraging use of electric vehicles as diesel and petrol phased out.
- Concern at EV range for long distance travel.
- · Chargers being installed across the country.
- We are fortunate that nearly all our houses have off-street parking major problem in other areas.
- Fly less unless new developments, eg hydrogen or "bio-fuels" made from green hydrogen.

Plastic & Recycling

- Concern at excessive use of plastic causing pollution
- Much plastic in not recycled by BDBC, even when marked as recyclable
- Hope new developments will allow local recycling of all types of plastic
- Consumers should minimise plastic use and pressure shops and suppliers to use less packaging

Risks and Opportunities

- · Very expensive to green every existing house
- Subsidies impractical if impact nearly everyone!
- Avoid buying everything from China
- Research needed for new technologies + cheaper:
 - batteries and solar panels using less precious/scarce metals
 - less obtrusive wind turbines
 - hydrogen generation and conversion into bio -fuels
 - ..

Farming Emissions

- There may be restrictions on methane emissions, especially from cattle
- There may also be restrictions on nitrates, especially on muck -spreading: delaying planning
- · Already see higher costs of fuel and fertiliser
- We await developments on tractors and HGVs, possibly using hydrogen rather than batteries?

Who does what?

- · Individuals can choose to be more careful!
- Government likely to enforce this with persuasion, legislation and taxation – tax oil and gas like petrol?
- · Less impact on local councils except to reduce own use.
- High fuel prices (gas, electricity and petrol) already enforcing efficiency.
- Research should create new opportunities, especially for UK manufacture, and market forces should cut prices.
- Hopefully home heating and electric vehicles will become more affordable!

Appendix B

Ashmansworth Parish Council Police Report

Apologies for not being able attend the meeting.

Ashmansworth is a village that is located in the Basingstoke and Deane district in Hampshire with the neighbouring village of Crux Easton. This resides close to both the Thames Valley border of Newbury and Test Valley border of Andover. Furthermore, this police report will outline the last 365 days of occurrences involved in and around the village.

Road Related Incidents x2

- Broken down vehicle on blind bend. No Further Action.
- White van has stopped blocking half the lane, unsure if RTC has happened or not. No Further Action.

Concern for Safety

• SOS message pinged from a mobile by mistake; officers attended and found everything to be ok as the person's phone had been malfunctioning.

Suspicious Person

Unknown person trying to sell items to them on their doorstep. A Man claiming to be an
ex-offender from Middlesbrough selling household goods. Police advice is that these
people are called Nottingham Knockers who tend to sell miscellaneous household items
for inflated prices. They will often say they are on some kind of scheme from getting out
of prison or something similar.

Please warn your neighbours, particularly elderly or vulnerable neighbours, not to open the door to strangers, buy, or sell on the doorstep.

- **Do Not** deal with Nottingham Knockers.
- **NEVER** allow Nottingham Knockers into your home.
- **Do Not** pay CASH/CARD on the doorstep.

Be aware of Nottingham Knockers visiting your neighbourhood and report any such activity immediately to police. By doing this, you may well prevent another person falling into the cycle of repeated visits and cash hand overs. No suspect identified.

Firearms x4

Management of those who are holders of Shotgun licences.

Please continue to report to the police if you believe to be a life threatening or dangerous situation at the time call 999. If you do not need an officer straight away call 101 or make a report via Hampshire Constabulary. Report any suspicious activity that includes people and cars, due to being quite a rural location please report any rural crime such as theft from farms and hare coursing as that is a priority.
